RIVERTOWN DANCE CLUB **MEMBERSHIP TERMS AND CONDITIONS**

The Rivertown Dance Club was founded in 1949, as the Mr. and Mrs. Club of Columbus. It is a private social club for couples with an interest in dance. The club holds monthly events featuring live bands, or recorded music, playing a variety of dance tunes. Even if your interest is not totally in dancing, the variety of bands, music and atmosphere are enjoyable for listening and socializing with friends. The evening is always fun, and you will develop friendships that will last a lifetime.

The Rivertown Dance Club is a membership organization. Much planning and scheduling goes into the monthly events and the calendar is set over a year in advance. Membership dues allow for an elegant venue and quality musical entertainment.

The Rivertown Dance Club requires no application or joining fees. Dues are *currently* \$90 per membership (couple or single) per quarter, regardless of attendance. Dues are electronically billed in advance at the end of each quarter – March, June, September, December. *Payment is due upon receipt of statement.* Dues can be paid for an entire year, if desired. Failure to pay in a timely manner may result in an automatic resignation in bad standing.

In times of serious illness or financial hardship, members may apply for a 90 day Leave of Absence.

Once a quarter, the Rivertown Dance Club hosts a dinner before the dance for an additional charge - *currently* \$60 per couple. This is also billed, in arrears, on the quarterly statement. ALL members have a *standing* dinner reservation. The meal is optional, and members can choose to attend only the dance. If members choose not to attend the meal, members must cancel dinner reservations by a given deadline. If meals are not cancelled by the deadline and members do not attend the dinner, members *will be charged* for the meals. No cancellations can be accepted after the deadline.

All dances offer a bar which serves alcoholic and non-alcoholic beverages. Cash and credit cards are accepted. No outside food or beverages are allowed.

All new members are given an official club name tag and are encouraged to wear it to each event. Additional name tags will be charged to the member for a nominal fee.

All members are required to assist with hosting responsibilities. Hosting is scheduled well in advance and printed in the club newsletter. Currently, each membership hosts approximately every 12 to 18 months.

The dress code is always “business or dressy casual” (no jeans, shorts or tee shirts) unless specified otherwise. There are occasional formal and themed events throughout the year. Events are scheduled in advance, put on the official club calendar, published in the monthly digital newsletter, and posted on the website. Current and upcoming events are shared on Facebook.
